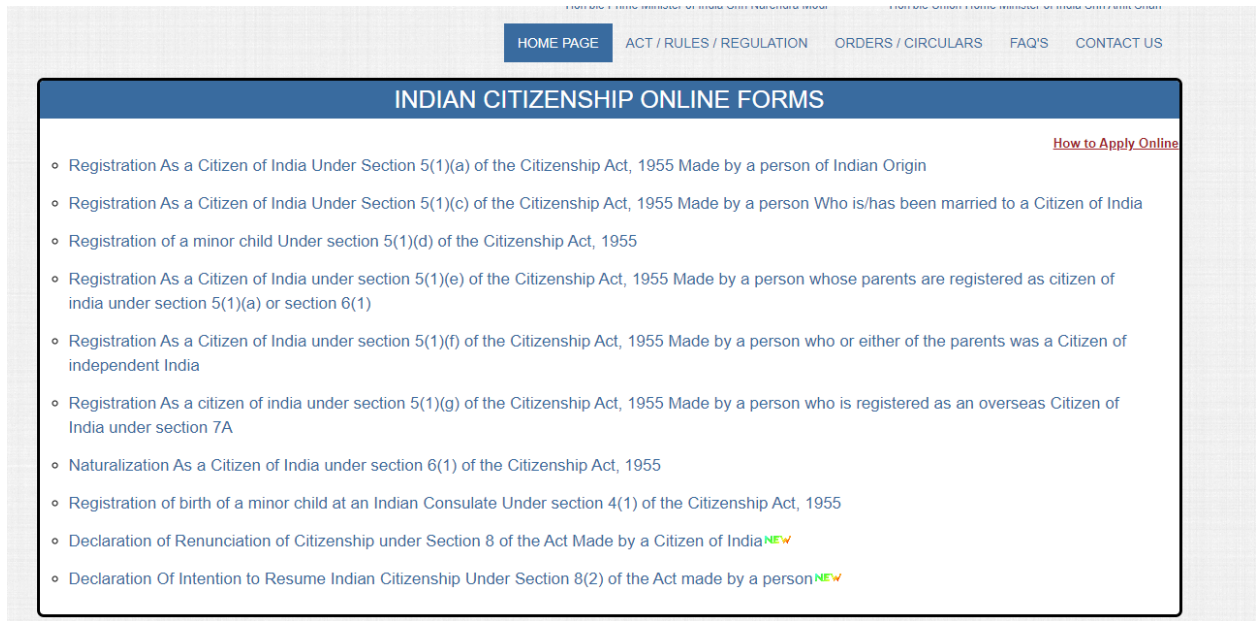
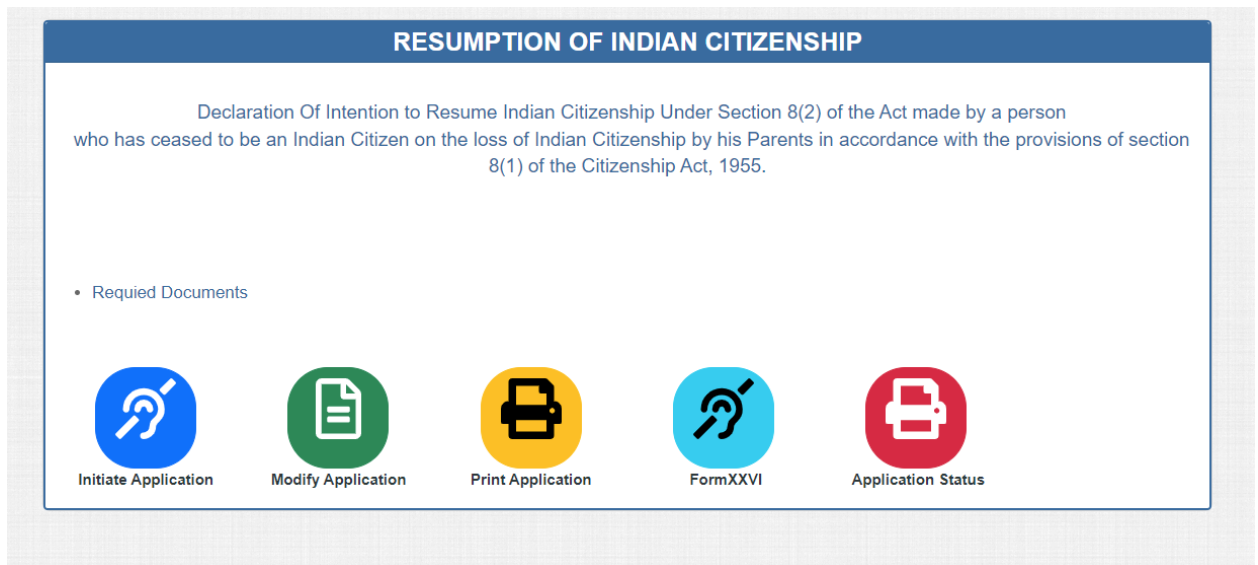


1. To submit an application for declaration of renunciation of Indian Citizenship, the one would visit the URL <https://indiancitizenshiponline.nic.in>

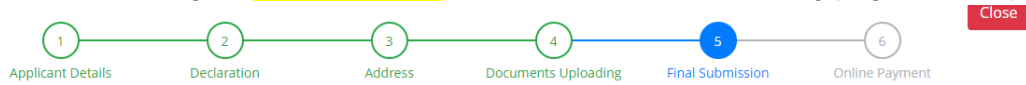

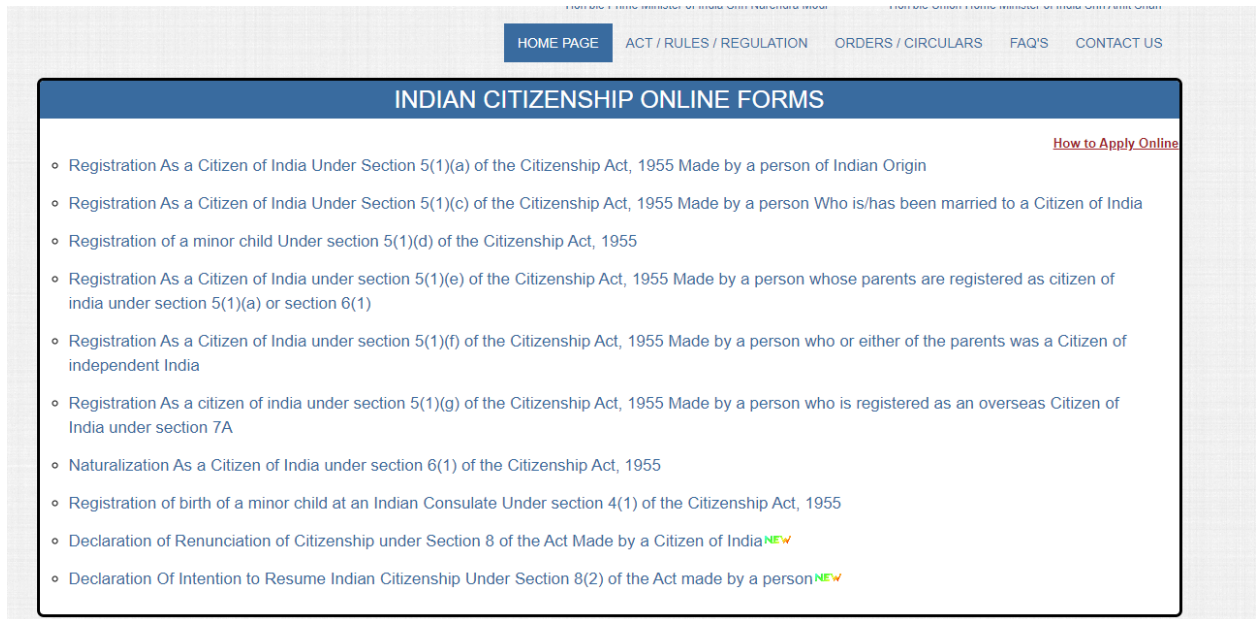

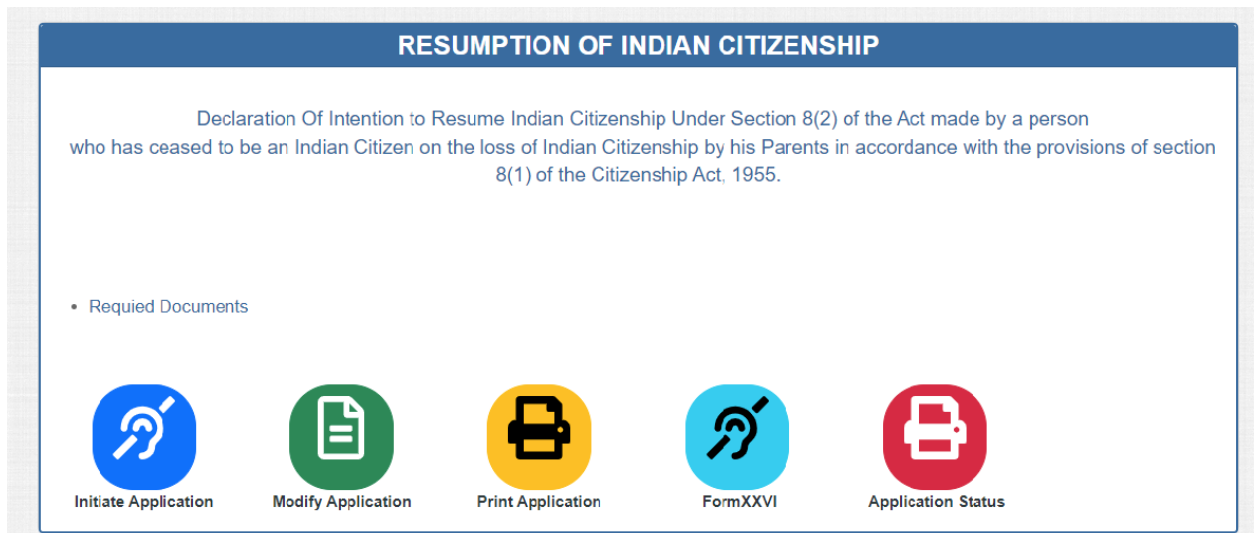
